



**MEMORANDUM OF UNDERSTANDING**  
**Between**  
**YUANPEI UNIVERSITY OF MEDICAL TECHNOLOGY**  
**And**  
**UNIVERSITAS MUHAMMADIYAH SURABAYA**

**PREAMBLE**

Following discussions and exchanges of correspondence between Universitas Muhammadiyah Surabaya and Yuanpei University of Medical Technology, a formal memorandum of understanding is made between, Universitas Muhammadiyah Surabaya and Yuanpei University of Medical Technology. Universitas Muhammadiyah Surabaya and Yuanpei University of Medical Technology desire to establish certain cooperative programs beneficial to respective educational institutions and to promote the development of joint studies, research and training activities, and other educational programs of mutual interest.

**AGREEMENT**

In contemplation of the relationship to be established and valuable consideration, the parties agree as follows:

1. This Memorandum of Understanding (“MOU”) replaces all previous communication and exchange of correspondence between the parties, and subsequent discussions, agreements and understandings, whenever verbal or in writing, is subsumed by this MOU.
2. This MOU is designed to facilitate and develop genuine and mutually beneficial study programs, research relationships and exchange programs.
3. It is agreed that Universitas Muhammadiyah Surabaya and Yuanpei University of Medical Technology will cooperate acting as independent participants to promote the following:
  - a. Visit by and exchange of students
  - b. Visit by and exchange of faculty and staff
  - c. Collaborative research in any field of interest common to both universities
  - d. Joint research activities
  - e. Joint or dual degree programs
  - f. Special short-term academic programs
  - g. Joint cultural programs
  - h. Participation in academic activities including workshops, conferences, and meetings


4. This MOU is incorporated into, and will provide the foundation and framework for the particular projects developed by academic and administrative units from the two institutions and embodied in the implementation agreements.
5. This Memorandum of Understanding may be modified through the mutual discussion and consent of the two universities, and shall remain in effect from the date of signature for an initial period of five years. Thereafter it shall be automatically renewed each year; however, after the initial period either university may terminate the agreement by giving six months written notice of such intent.
6. This MOU may be renewed for a period by mutual consent of Universitas Muhammadiyah Surabaya and Yuanpei University of Medical Technology. Renewals shall be in writing and subject to the same terms and conditions set forth herein, and shall be contingent upon a satisfactory performance evaluation by the parties. The respective International Programs Offices, or the equivalent, will initiate the evaluation.
7. Resources for implementation of this MOU may come from either party, depending upon budgetary availability. Neither party is obligated to expend any resources in connection with this MOU. No implementation of any portion of this MOU or commencement of any specific projects may be initiated prior to the written assurance of adequate budgetary resources.
8. This MOU shall not be construed to create a relationship of partners, brokers, employees, servants, joint ventures or agents as between the parties. The parties to this MOU are acting as independent participants.
9. Either party shall have the absolute right to terminate this MOU with or without cause upon thirty (30) days prior written notice to the other party.
